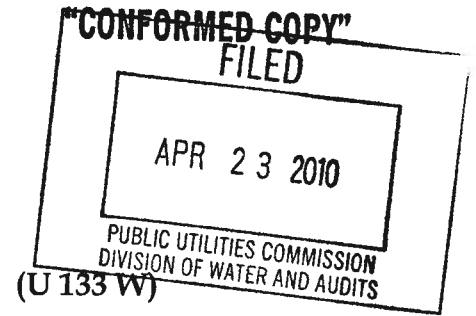

SUBJECT: Update Preliminary Statement, Conservation OII Memorandum Account

PURPOSE

This advice letter filing is in compliance with Decision No. ("D.") 10-04-001, which modifies D. 08-02-039 that authorized memorandum accounts to track legal and regulatory expenses incurred while participating in Order Instituting Investigation No. 07-01-022.

GSWC seeks the California Public Utilities Commission's ("Commission") approval to revise the existing Preliminary Statement, Part P, to reflect the language approved in D.10-04-001. The Conservation OII Memorandum Account ("Memo Account") tracks unanticipated expenses incurred while participating in the Commission's Conservation Order Instituting Investigation No. 07-01-022, pursuant to Decision No. ("D.") 08-02-036.

BACKGROUND

On February 29, 2008 the Commission issued D. 08-02-036, which authorizes a memorandum account for Class A water utilities to track legal and related expenses incurred in participating in the Commission's Conservation OII proceedings. Specifically, Ordering Paragraph No. 5 of Decision No. 08-02-036 states,

A memorandum account is authorized for Suburban and other Class A water utilities to track legal and related expenses incurred in participating in this proceeding from the date of issuance of this order instituting investigation (OII). Costs of preparing applications consolidated with this proceeding, whether incurred prior or subsequent to the issuance of the OII, shall not be tracked in the authorized memorandum accounts. Suburban's request to track legal and consulting expenses incurred prior to the issuance of this OII is denied.

Pursuant to Ordering Paragraph No. 5 in D.08-02-036, Golden State Water Company filed Advice Letter 1273-W on March 28, 2008. Advice Letter 1273-W was approved on April 28, 2008. However, Advice Letter 1273-W limited recovery of unanticipated legal and regulatory expenses to the Phase 2 portion of the OII proceeding only.

Ordering Paragraph No. 1 in D. 10-04-001 states, in part,

- 1. Apple Valley Ranchos Water Company, California-American Water Company, California Water Service Company, Golden State Water Company, Great Oaks Water Company, Park Water Company, San Gabriel Valley Water Company, San Jose Water Company, and Valencia Water Company may establish memorandum accounts to track legal and related expenses for participating in this proceeding from the date of issuance of this Order Instituting Investigation.*

Pursuant to Ordering Paragraph No.1 in D.10-04-001, GSWC submits this advice letter to update its existing Preliminary Statement, Part P to coincide the provisions detailed in D.10-04-001.

MEMORANDUM ACCOUNT TREATMENT

GSWC is aware that a memorandum account is not a guarantee of eventual recovery of expenses, nor is it carried as a regular account under the uniform system of accounts for water utilities. It is carried "off the books", as a memorandum account. Further, it is also known that Commission policy on memorandum account treatment has always been that the burden of proof of the reasonableness of expenses charged to the account is the responsibility of the utility requesting reimbursement of such expenses.

TIER DESIGNATION

Pursuant to D. 07-01-024 and D.10-04-001, this advice letter is submitted with a Tier 1 designation.

EFFECTIVE DATE

GSWC requests that this advice letter filing become effective on date it is filed with the Commission's Division of Water and Audits.

PROTEST AND RESPONSES

Anyone may respond to or protest this advice letter. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- (1) The utility did not properly serve or give notice of the advice letter;
- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

A response or protest must be made in writing or by electronic mail and must be received by the Water Division within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:


If you have not received a reply to your protest within 10 business days, contact this person at 909-394-3600 ext. 682.

P. CONSERVATION OII MEMORANDUM ACCOUNT

Golden State Water Company ("GSWC") shall maintain a Conservation OII Memorandum Account ("Memo Account") to track legal and related expenses in participating in the Commission's proceeding from the date of issuance of the Commission's Order Instituting Investigation ("OII").

1. Purpose

The purpose of the Memo Account is to track legal and regulatory related expenses associated in participating in the Conservation OII from the date of issuance. (C)

2. Applicability

The Memo Account does not have a rate component.

The Memo Account shall include:

The costs will include unanticipated legal and regulatory related expenses associated with participating in the Conservation OII proceedings. (C)

GSWC shall maintain the Memo Account by making entries at the end of each month as follows:

- a. A debit entry shall be made to the Memo Account at the end of each month to record the expenses discussed above.
- b. Interest shall accrue to the Memo Account on a monthly basis by applying a rate equal to one-twelfth of the 3-month Commercial Paper Rate, as reported in the Federal Reserve Statistical Release, to the average of the beginning-of-month and the end-of-month balances.

3. Effective Date

The Memo Account shall be made effect on the filing date of Advice Letter 1394-W. (C)

4. Disposition

GSWC will seek recovery of the expenses recorded in the Memo Account in its next general rate case or by filing a Tier 3 advice letter. (C)
