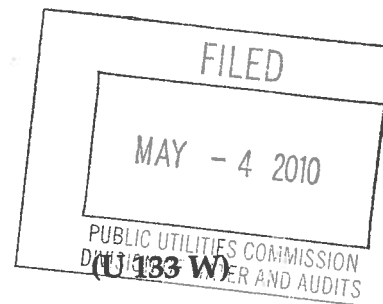

In compliance with Decision No. 02-01-034, GSWC hereby submits this advice letter to update the eligibility income guidelines in its lifeline rate plan, also known as California Alternate Rates for Water (CARW) program. The CARW eligibility guidelines are patterned after those established in the California Alternate Rates for Energy (CARE) Program for energy utilities. This filing, when approved, will increase the eligibility income levels in GSWC's CARW program to match eligibility income guidelines in the energy utilities CARE program. **Because this advice letter is not seeking authorization to increase rates, a resolution will not be needed to approve this advice letter.**

Background

On January 9, 2002, the California Public Utilities Commission (Commission) issued Decision No. 02-01-034, granting GSWC authority to establish the CARW program in its Region II and Region III service territories. The CARW program provides a 15% rate reduction to eligible residential customers on each component of their water bill. Ordering Paragraph No. 1 of Decision No. 02-01-034 orders GSWC to set the eligibility income guidelines at 175% of the federal poverty guidelines. These eligibility income guidelines are revised annually by the Commission and go into effect June 1. On April 23, 2010, the Commission established the 2010/2011 eligibility income guidelines, effective June 1, 2010. This advice letter is being filed to reflect the updated eligibility income guidelines on GSWC's CARW tariffs.

Compliance

GSWC has revised its Schedule No. LI-10 and Form No. 20 to reflect the annual increase to eligibility income. The table below shows the increase to each level of the eligibility income.

Tier Designation

Pursuant to D. 07-01-024, this advice letter is submitted with a Tier 1 designation.

Effective Date

Pursuant to Resolution E-3524, GSWC requests approval of this advice letter allowing these tariffs to become effective June 1, 2010.

Protest and Responses

Anyone may respond to or protest this advice letter. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- (1) The utility did not properly serve or give notice of the advice letter;
- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

A response or protest must be made in writing or by electronic mail and must be received by the Water Division within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:



APPLICABILITY

Applicable to residential water service for domestic use rendered to low-income households where the customer meets all the Special Conditions of this rate schedule.

TERRITORY

Within all Customer Service Areas served by the Company in Region II and Region III.

RATES

Fifteen percent (15%) discount applied to the regular filed tariff in the applicable Customer Service Area.

SPECIAL CONDITIONS

1. Low-Income Household: A Low-Income Household is a household where the total gross annual income from all sources is no more than shown on the table below based on the number of persons in the household. Total gross income shall include income from all sources, both taxable and nontaxable.

SPECIAL CONDITIONS

2. Application and Eligibility Declaration: An Application and eligibility declaration on a form authorized by the Commission is required for each request for service under this schedule. Renewal of a customer's eligibility declaration will be required, at least, every two years.
3. Commencement of Rate: Eligible customers shall be billed on this schedule commencing with the next regularly scheduled billing period that follows receipt of application by the Utility.
4. Verification: Information provided by the applicant is subject to verification by the Utility. Refusal or failure of a customer to provide documentation of eligibility acceptable to the Utility, upon request by the Utility, shall result in removal from this rate schedule.
5. Notice From Customer: It is the customer's responsibility to notify the Utility if there is a change of eligibility status.
6. Rebilling: Customers may be re-billed for periods of ineligibility under the applicable rate schedule.
7. Mobile home Park and Master-metered: A reduction will be calculated in the bill of a mobile home park and master-metered customers, who have sub-metered tenants that meet the income eligibility criteria, so an equivalent discount (15%) can be passed through to eligible customer(s). (T)
