

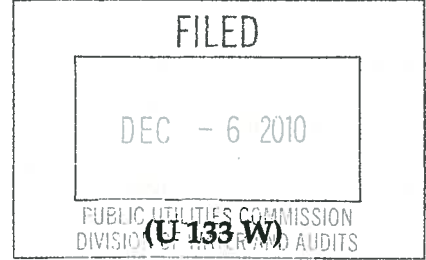

PURPOSE

GSWC is seeking authorization to implement a temporary surcharge in its Region III customer service areas to recover the revenue shortfall caused by the variance between interim rates (which were in place since January 1, 2010) and final rates implemented on December 1, 2010. The final rates in Region III were adopted in California Public Utilities Commission's ("Commission") Decision No. ("D") 10-11-035, which was approved and issued on November 19, 2010.

Ordering Paragraph No. 13 in D. 10-11-035 authorized GSWC to file the above referenced tariff sheets. Specifically, Ordering Paragraph No. 13 states,

- 13. The surcharge to true-up the interim rates shall be collected over the remainder of this rate case cycle. The tariff implementing the surcharge may be included in the filing authorized in Ordering Paragraph 11 or filed by Tier 1 advice letter within 5 days of the effective date of the rate increase authorized by this decision.*

GSWC has calculated the difference between the interim rates and final rates for the period of January 1, 2010 through November 30, 2010. As shown in the supporting workpapers, the total revenue shortfall is \$12,319,496. In compliance with Ordering Paragraph No. 13, GSWC is requesting to recover the shortfall over a 24-month period with a surcharge of \$0.20214 per Ccf applied to the quantity rates of its Region III rate schedules listed above, beginning on January 1, 2011. The proposed surcharge will be in place from January 1, 2011 through December 31, 2012, the remainder of the current general rate case cycle.

The present rates in Region III became effective on December 1, 2010, by Advice Letter No. 1417-W. Advice Letter No. 1417-W implemented the 2010 general rate increase authorized in D.10-11-035.

RATE IMPACT

If this advice letter is approved with the tariffs proposed herein, a residential customer on Schedule No. R3-1-R with a 5/8 x 3/4" meter, using 17 Ccfs per month will experience an increase of 3.44 or 5.2% from \$65.56 to \$69.00.

Two copies of detailed workpapers supporting the proposed rate increase and rate calculations are being supplied to the Commission Staff under a separate cover.

EFFECTIVE DATE

As this is a Tier 1 filing, GSWC will make the tariffs herein effective on January 1, 2011.

PROTEST AND RESPONSES

Anyone may respond to or protest this advice letter. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- (1) The utility did not properly serve or give notice of the advice letter;
- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

A response or protest must be made in writing or by electronic mail and must be received by the Water Division within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:


If you have not received a reply to your protest within 10 business days, contact this person at 909-394-3600 ext. 682.

Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform the Water Division, within the 20 day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

The actions requested in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.

No individuals or utilities have requested notification of filing of tariffs. Distribution of this advice letter is being made to the attached service list in accordance with General Order No. 96-B, Section III-G. In accordance with Resolution W-4664, notice is not required. GSWC will include notice of the rate change on customer bills during the first billing period the increase is in effect.

2. The company shall not be required to install new mains to make this service available.
3. The annual service charge will be paid in advance and bills will be computed and rendered monthly based on the total quantity of water delivered.
4. The customer, when requiring irrigation water, shall notify the Company at least twenty-four (24) hours in advance, indicating the date and hour for commencement of such service.
5. No customer shall be eligible for service under this schedule unless irrigating five (5) or more acres of land for citrus or other commercial crops.
6. Service under this schedule is subordinate to all other service schedule offered in this tariff areas and is subject to interruptions in emergencies or at the Company's discretion. The Company will not be liable for damage occasioned by interruption of service supplied under this schedule.

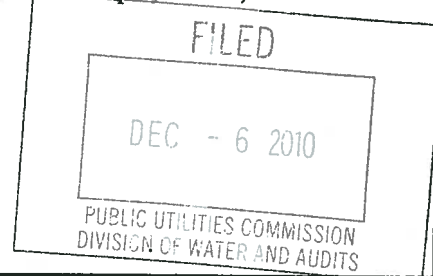
